**Deadline to submit: August 20, 2010**

**Specifications:** All photographs, black & white, color, non-silver, computer-manipulated, etc. are eligible. There is no size limitation.

**Fees:** \$30 - for up to 5 images. Please make the check out to DVAEC indicate Juried Photo Fee on the memo line. We also accept cash and Visa, Mastercard and Discover.

TWO CALLS:

## 1 - Emerging Photographers

Exhibition dates: October 16, 2010 – January 2, 2011. Open to all photographers new to the medium, over the age of 18. One photographer will be selected for a solo show in 2011.

## 2 – Professional/Established Photographers

Exhibition dates: October 2, 2010 – October 31, 2010. Open to all fine-art photographers.

HOW TO SUBMIT:

**Specifications:** All photographs, black & white, color, non-silver, computer-manipulated, etc. are eligible. Submit images on CD saved in a folder labeled with your last name. Images must be saved as JPEGs at medium compression at 72dpi by 900 pixels in the longest dimension for viewing. Please write your name on the CD with a permanent marker.

The following items must be (burned) on your CD:

1. Each image should be titled as follows: title1.jpeg, title 2.jpeg, title 3.jpeg etc.
2. A Word document listing the following:
  - Your name, address, phone number, and email address.
  - The titles, dimensions, media and year created for your submissions.
  - If your work is for sale, indicate sale price and if not for sale indicate NFS. See our conditions of exhibition for commission taken from sales.

If you are accepted to the exhibit you must read and sign the form below and bring it to the Center. Fill out the Artists' contact information. ID tags to be kept with the work will be attached to an email notifying your acceptance.

CONDITIONS OF EXHIBITION:

Artwork for exhibition must have been completed in last 2 years and not previously exhibited at the DVAEC. Artwork must remain on view for the duration of the exhibit.

Artist is solely responsible for shipping, delivery/pick up, and any unusual installation requirements.

All work must be received ready to hang. Each framed piece must have eye-screws and wire in place for hanging, preferably within the first 1/3 of the top of the picture frame or higher.

The DVAEC will insure the artwork from the time of delivery until the designated pick up time (for an amount that shall not exceed the sale price less the commission). Any work left at the DVAEC for longer than the designated pick-up dates may be disposed of at the Center's discretion.

The DVAEC will retain a 30% commission for any works sold during the show, a 20% commission for DVAEC members. Submission of an entry indicates the artist commits the work to this show unless the juror does not accept work.

Submission of an entry constitutes permission to photograph it for publicity purposes and agreement with all conditions set forth in this prospectus.
